- (b) an adoption order made in the Isle of Man or any of the Channel Islands; or
- (c) an overseas adoption within the meaning of section 4 of the Adoption Act 1968; or
- (d) any other adoption order made under any law in force outside the United Kingdom which, in the opinion of the Secretary of State, is analogous to any of the aforesaid enactments;

and "adoption" shall be construed accordingly:".

2. In paragraph (2) of Article 17 (unemployability allowances) for the words "£364 a year" there shall be substituted the words " £468 a year

#### EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order in Council further amends the Order in Council of 25th September 1964.

Article 1 increases rates of retired pay, pensions, gratuities and allowances in respect of disablement or death due to service in the naval forces during the 1914 World War and after 2nd September 1939 by substituting in the 1964 Order new Tables contained in Schedules 2, 3, 4, 6 and 7 for those set out in the Schedules to the Order of 17th September 1975.

Article 2 amends the definition of "adopted" and raises from £364 a year to £468 a year the maximum amount of annual earnings which may be received by a member while deemed to be unemployable for the purposes of an award of unemployability allowance.

Article 3 is formal and makes provision for the coming into operation of this Order and matters consequential thereon.
