 (5) The Cleaning of the exterior of buildings.
 (6) The operation of Ornamental Fountains or Cascades

including anywhere water is recycled.

(7) The Operation, in relation to any building or other premises, of any cistern which flushes automatically, during any period when the premises are wholly or substantially unoccupied.

The aforementioned prohibitions will be announced from time to time in newspapers circulating within the areas of

supply.

THIRD SCHEDULE

Limitations

The Authority may limit, at such times and for such periods as it considers expedient, the use of mains water supplied for any purpose to all or any premises within the

areas of supply specified in the First Schedule, whether used by Domestic Consumers, Industrial Consumers, Agricultural Consumers, Local Authority Consumers or any other Consumer. The times and periods of the restrictions will be announced from time to time in newspapers circulating within the areas of supply.

Generally

(1) Nothing referred to in the Second Schedule shall be treated as prohibiting the use of water for the purposes of the prevention of any Public Health Hazard or in the per-formance of any Public Health Service or Health Service whether in pursuance of medical treatment or otherwise or

for the purposes of Fire-Fighting.
(2) In the Second and Third Schedules and Note 1

above:

"Mains Water" means water supplied by means of the

Authority's mains whether by meter or otherwise.

"Health Service" includes a service provided by or in the discharge of their functions by an Area Health Authority or Local Authority.

(3) The Order shall not come into effect until a period of 72 hours has elapsed commencing with the date on which a notice of the making of the Order has been published or
