

CORNWALL COUNTY COUNCIL

The County of Cornwall (Leedstown) (Experimental Prohibition of Waiting) Order 1976

Notice is hereby given that the Cornwall County Council propose to make an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 the effect of which will be to regulate traffic at Leedstown for an initial period of six months from the date the Order comes into operation by prohibiting the waiting of vehicles at any time in any of the lengths of road specified in the Schedule hereto.

Exceptions will be provided in the Order to allow a vehicle to wait for (a) periods not exceeding 2 hours (return prohibited within 1 hour) if the vehicle is a disabled person's vehicle displaying a disabled person's badge and a parking disc in accordance with the appropriate regulations and (b) so long as may be necessary to allow a person to board or alight from the vehicle; to enable goods to be loaded or unloaded; to enable postal packets to be delivered or collected; in connection with statutory powers or duties, building operations, the maintenance or improvement of the lengths of road or of the services therein; to take in petrol, oil, water or air from a garage; and in connection with a funeral.

Objections to this proposal, together with the grounds on which they are made, must be sent in writing to the undersigned by the 3rd September 1976.

A copy of the proposed Order, together with a map showing the lengths of road referred to therein, and a statement of reasons for proposing to make the Order, will be available for public inspection between the hours of 9.30 a.m.-12.30 p.m. and 2.30 p.m.-4 p.m. Mondays to Fridays inclusive, at the County Hall, Truro, and at the offices of the Kerrier District Council, South Terrace, Camborne.

Lengths of road at Leedstown

1. Helston-Hayle Road (B.3302)
 - (a) south-western side, between points 20 yards north-west and 26 yards south-east of its junction with the Goldsithney Road;
 - (b) north-eastern side, between points 5 yards north-west and 30 yards south-east of its junction with the Praise-Nine Maidens Road.
2. Goldsithney-Praise-Nine Maidens Road (B.3280), between points 15 yards south-west and 73 yards north-east of its junction with the Helston-Hayle Road.

The County of Cornwall (Camborne) (Various Streets) (Restrictions on Waiting) (Amendment) Order, 1976

Notice is hereby given that the Cornwall County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 the effect of which will be:

- (i) to prohibit the waiting of vehicles at any time in that length of Commercial Square (Unclassified) at Camborne which extends around the centre island and fountain between points 3 yards and 24 yards south of its junction with Commercial Street.

Exceptions will be provided in the Order to allow a vehicle to wait for (a) periods not exceeding 2 hours (return prohibited within 1 hour) if the vehicle is a disabled persons vehicle displaying a disabled persons badge and a parking disc in accordance with the appropriate Regulations and (b) so long as may be necessary to allow a person to board or alight from the vehicle; to enable goods to be loaded or unloaded; to enable postal packets to be delivered or collected; in connection with statutory powers or duties, building operations, the maintenance or improvement of the lengths of road or of the services therein; to take in petrol, oil, water or air from a garage; and in connection with a funeral;

- (ii) to revoke the existing 30 minute limited waiting restrictions operating between 9 a.m.-6 p.m. on weekdays on

either of the length of road specified in the Schedule hereto.

Objections to these proposals together with the grounds on which they are made, must be sent in writing to the undersigned by the 3rd September 1976.

2. Chapel Street (Unclassified)—western side—between points 5 yards and 25 yards south of its junction with Gurneys Lane.

The County of Cornwall (Pentewan) (Prohibition of Waiting) Order, 1976

Notice is hereby given that the Cornwall County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 the effect of which will be:

- (i) to prohibit the waiting of vehicles at any time in any of the lengths of road specified in the Schedule hereto.

Exceptions will be provided in the Order to allow a vehicle to wait for (a) periods not exceeding 2 hours (return prohibited within 1 hour) if the vehicle is a disabled persons vehicle displaying a disabled persons badge and a parking disc in accordance with the appropriate Regulations and (b) so long as may be necessary to allow a person to board or alight from the vehicle; to enable goods to be loaded or unloaded; to enable postal packets to be delivered or collected, in connection with statutory powers or duties, building operations, the maintenance or improvement of the lengths of road or of the services therein; to take in petrol, oil, water or air from a garage; in connection with a funeral; and if the vehicle is waiting at a duly authorised parking place.

- (ii) to amend existing traffic regulation measures operating in Pentewan to give effect to the foregoing.

SCHEDULE

Lengths of road at Penewan

1. Pentewan Hill (Class III)—from its junction with Pentewan Square for a distance of 220 yards in a north-easterly direction.

2. The whole of Pentewan Square (Class III)—except:

- (i) northern side—the rectangular area of road measuring 64 feet by 16 feet with its larger side situated 11 feet south of the northern kerbing of the Square and extending in a westerly direction from a point 15 feet south-east of the junction with Glentowan Road; and

- (ii) south-western side—the rectangular area of road measuring 40 feet by 16 feet situated immediately adjacent to the south-western wall of the Square and extending in a north-easterly direction from a point 48 feet north-east of the junction with West End.
