The Nottinghamshire County Council (Various Streets, Kirkby-in-Ashfield) (Prohibition and Restriction of Waiting) Order 1976.

Notice is hereby given that the Nottinghamshire County Council propose to make the following Order under the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

1. Waiting will be prohibited at any time in the lengths of road specified in Schedule 1 to this notice.
2. Waiting will be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the length of road specified in Schedule 2 to this notice.
3. Waiting will be restricted to 30 minutes, return prohibited within one hour, between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive, in the length of road specified in Schedule 3 to this notice.

Exemptions will be provided for vehicles to wait with police permission, or for passengers to board or alight, for the loading or unloading of goods, for enabling works to be carried out in or adjacent to the roads. The usual exemptions for disabled person's vehicles will be provided.

A copy of the proposed Order, a statement of reasons and a plan showing the affected roads, may be inspected during normal office hours at the office of the Director of Administration and Legal Services, Ashfield District Council, Council Offices, Urban Road, Kirkby-in-Ashfield, Nottingham, or at my office at County Hall, West Bridgford, Nottingham.

Objections must be in writing, stating the grounds on which they are made, and sent to me not later than the 10th September 1976.

SCHEDULE 1

Lengths of Road at Kirkby-in-Ashfield in the District of Ashfield

Prohibition of Waiting at any Time and Extent of Restriction

1. *Lowmoor Road*, B.6021. Commencing at a point 25 yards north of Station Street junction terminating in a northerly direction at the southern boundary of Sherwood Street junction. Both sides.
2. *Kingsway*, B.6021:
 - (a) Commencing at a point 25 yards south of Diamond Avenue junction, terminating at a point 20 yards south of Kingsley Street junction. East side.
 - (b) Commencing at the centre line of Kingsley Street junction, terminating in a southerly direction at a distance of 25 yards. West side.
3. *Station Street*, B.6020:
 - (a) Commencing at a point 59 yards west of Lowmoor Road junction terminating at the Prohibition of Waiting 7 yards east of Ellis Street junction. North side.
 - (b) Commencing at the centre line of Factory Road junction, terminating at a distance of 30 yards in an easterly and westerly direction. North side.
 - (c) Commencing at a point 59 yards west of Lowmoor Road junction terminating at the eastern boundary of Morley Street. South side.
4. *Factory Road*. Commencing at Station Street junction, terminating in a northerly direction at a distance of 30 yard. Both sides.
5. *Diamond Avenue*, B.6020. Commencing at a point 59 yards east of Lowmoor Road junction terminating in an easterly direction at a distance of 52 yards. Both sides.

6. *Unity Street*. Commencing at Lowmoor Road, terminating in an easterly direction at a distance of 75 yards. Both sides.

7. *Prospect Street*. Commencing at Lowmoor Road junction, terminating in an easterly direction at a distance of 44 yards. Both sides.

SCHEDULE 2

Length of Road at Kirkby-in-Ashfield in the District of Ashfield

No waiting between 8 a.m. and 6.30 p.m., Mondays to Saturdays inclusive

Kingsway, B.6021. Commencing at a point 25 yards south of the centre line of Kingsley Street, terminating at the northern boundary to St. Thomas Avenue. East side.

SCHEDULE 3

Length of Road at Kirkby-in-Ashfield in the District of Ashfield

Waiting limited to 30 minutes with return prohibited within 1 hour between 8 a.m. and 6.30 p.m., Mondays to Saturdays inclusive, and extent of restriction.

Kingsway, B.6021. Commencing 25 yards south of the centre line of Kingsley Street junction, terminating in a southerly direction at a distance of 185 yards. West side. (537)

OXFORD CITY COUNCIL

The City of Oxford (Marlborough Road) (No Entry) Order 1976

Notice is hereby given that pursuant to arrangements made under section 101 of the Local Government Act 1972, the Oxford City Council as duly authorised agent for and on behalf of the Oxfordshire County Council propose to make the above Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

Should this Order come into effect motor vehicles travelling in any of the lengths of road listed in column 1 of the Schedule to this notice will not be permitted to enter the length of road specified in relation to that road in column 2 of the Schedule. The restriction will not apply to pedal cyclists.

Full details of the proposal are in the draft Order which, together with a statement of the Council's reasons for proposing to make the Order and a map showing the restricted areas, may be examined at the City Secretary and Solicitor's Office, St. Aldate's Chambers, Oxford and the City Engineer's Drawing Office, 117/119 St. Aldate's, Oxford, between the hours of 9 a.m. to 1 p.m. and 2 p.m. to 4 p.m. on Mondays to Fridays.

If you wish to object to the proposed Order you should send the grounds for your objection in writing to the undersigned by the 13th September 1976.
