The Rugby Borough Council (Footpath R67 Lutterworth Road, Pailton) Public Path Diversion Order 1976

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 19th July 1976, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Rugby Borough Council as an unopposed Order.
