West Sussex County Council (Hurstpierpoint and Albourne) Public Paths (Nos. 11 and 1d) Diversion Order, 1976

Notice is hereby given that the above-named Order, made on 30th July 1976 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the West Sussex County Council.

The effect of the Order, if confirmed without modification, will be to divert (1) the public footpath (Path No. 1d) in the Parish of Albourne, by stopping up the path commencing at its junction with the maintainable highway (Reeds Lane), extending south-eastwards for a distance of approximately 340 feet to its junction with the Parish boundary, and (2) part of the public footpath (Path No. 11) in the Parish of Hurstpierpoint, by stopping up the path commencing at its junction with public footpath (Path No. 1d), extending south-eastwards for a distance of approximately 350 feet, and substituting for those paths a new length of public footpath, a minimum width of 6 feet, commencing on the maintainable highway (Reeds Lane) at a point approximately 240 feet north-east of its original junction, extending southwards on an eastern headland for a distance of approximately 560 feet, thence south-eastwards for a distance of approximately 140 feet, to join the south-eastern end of the length of path proposed to be stopped up.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Office of the County Secretary, County Hall, Chichester, and at the Office of the District Administrator, Mid Sussex District Council, Oaklands, Oaklands Road, Haywards Heath between 10 a.m. and 5 p.m. on Mondays to Fridays inclusive.

Any representation or objection with respect to the Order may be sent in writing to the County Secretary, County Hall, Chichester, Sussex and should be received on or before 10th September 1976 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the West Sussex County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

The effect of the Order as confirmed is to divert the public right of way running from a point approximately 370 feet south-east of Westfield Lane, South Elmsall and approximately 300 feet south of Broad Lane Primary School, South Elmsall for approximately 370 feet in a north-

westerly direction to Westfield Lane, South Elmsall at a point opposite 114 Westfield Lane, South Elmsall to a line running from the first mentioned point for approximately 180 feet south-west along the edge of the allotment gardens and then for approximately 320 feet north-west to Westfield Lane at a point opposite 126 Westfield Lane.

The County of Wiltshire (Footpath No. 24, Wroughton) Public Path Diversion Order 1976

Notice is hereby given that the above-named Order, made on 10th August 1976, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the Wiltshire County Council.

The effect of the Order, if confirmed without modifications, will be to divert a length of the public right of way known as Footpath 24 in the Parish of Wroughton as described below:

That length of Footpath No. 24 which runs from its junction with the road U.C.3069 at a point north of Overtown Farm in a general westerly direction to its junction with the road U.C.3065 shall be diverted at a point immediately north of Overtown Farm buildings to run in a general westerly direction past the farm buildings and along the southern edge of the wood to the end of the wood, and then in a southerly direction to rejoin its former route at a point shortly before its junction with road U.C.3065, so as to provide a more commodious route.
