WATER SHORTAGE

Notice of Application for Emergency Order relating to Abstractions from the River Bray at Leehamford Bridge

Whereas in view of an exceptional shortage of rain, a serious deficiency of supplies is threatened in the area of the South West Water Authority which is served from the Wistlandpound Reservoir, in the Parishes of Arlington, Bratton Fleming, Challacombe and Kentisbury in the North Devon District.

Notice is therefore given that in order to maintain an adequate supply of water the Authority is applying to the Secretary of State for the Environment for an Order pursuant to S. 1 and S. 3(4) of the Drought Act 1976 to enable it, for the period of the present emergency and for a period in any case, not exceeding six months:

- (a) To modify the conditions relating to the abstraction of water from the River Tavy at the Leehamford Bridge Intake at National Grid Reference SS 677 399 as contained in Licence to Abstract Water No. 14/50/08/0559/01 and 09/39, 45 and 12 so as to provide:
 - (i) that the residual flow in the River Bray immediately below the Intake shall be reduced from 13.55 t.c.m. (2.98 million gallons) in any period of 24 hours to 1.13 t.c.m. (0.25 million gallons) in any period of 24 hours.
 - (ii) that the Authority may abstract an additional 2.27 t.c.m. (0.50 million gallons) from the River Tavy at the Leehamford Bridge Intake.
- (b) To carry out associated works.

STOKE-ON-TRENT COUNTY COUNCIL

City of Stoke-on-Trent (Experimental Traffic Regulation) (No. 4) Order 1976

While the Order remains in force it enables the Council at any time to lay or to remove the authorised markings at or from any bus stop in a specified road or to adjust the position in the road of the authorised markings, as traffic conditions may require.

Other vehicles will be permitted to wait at bus stops with authorised markings, where necessary, for:

- 1 The removal of an obstruction to traffic.
- 2 The maintenance of the road and in exercise of statutory powers with permission of the Council, and
- 3 Reasons of emergency.
