The Trunk Road (Clapham Road and Tavistock Street, Bedford) (Restriction of Waiting) Order 197

The Secretary of State for the Environment proposes to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the London-Carlisle-Glasgow-Inverness Trunk Road (A6) known as Clapham Road and Tavistock Street, Bedford in the Borough of North Bedfordshire in the County of Bedfordshire.

The effect of the Order will be to vary the Trunk Road (Various Roads, Bedford) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1973 so that waiting restrictions:

- (a) will apply between the hours of 8 a.m. and 6.30 p.m. on any day other than a Sunday on the south-west side of Tavistock Street from a point 15 yards north-west of its junction with Tavistock Place to a point 15 yards south-east of its junction with Union Street and on the north-east side of Tavistock Street from a point 15 yards north-west of its junction with Chandos Street to its junction with Roff Avenue; and
- (b) will apply between the hours of 8 a.m. and 6.30 p.m. on any day other than a Sunday on the north-east side of Clapham Road from a point 34 yards south-east of its junction with Park Road West (Clarendon Street) to its junction with Roff Avenue and on the south-west side of Clapham Road from its junction with Union Street to a point 125 yards north-west of that junction.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, and to allow disabled persons vehicles as defined in the local authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975 to wait.
