DEVON COUNTY COUNCIL

The Devon County Council (Mill Street, Bideford) (One-Way, Prohibition and Restriction of Waiting) Order 1976

Notice is hereby given that the Devon County Council propose to make an Order under sections 1 and 84 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to prohibit the parking of vehicles at all times in that length of Mill Street (south-west side) which extends from its junction with Coldharbour to a point 40 metres (44 yards) south-east of that junction.

There will be exceptions in the proposed Order to allow waiting for the purposes of picking up and setting down of passengers, loading and unloading goods, and where necessary in connection with the maintenance of the road and the supply of gas, water and electricity.

An exception relating to disabled persons' vehicles will also be included.

Full details of the proposals are contained in the draft Order which, together with a map showing the length of road concerned and a statement of the Council's reasons for proposing to make the Order, may be examined during normal office hours, Monday to Friday, at either the Secretary's Office, Torridge District Council, Town Hall, Bideford or Room 304, Civic Centre, Barnstaple.

The Borough of Eastleigh (Fair Oak) (Prohibition of Waiting) Order 1976

Notice is hereby given that the Eastleigh Borough Council, pursuant to arrangements made under section 101 of the

Local Government Act 1972 with the Hampshire County Council propose to make an Order in exercise of the powers of the said County Council under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 the effect of which will be to prohibit the waiting of vehicles at any time on the lengths of road specified in the Schedule hereto.
