Public Footpath (No. 18, Bovington) Diversion Order 1976

Notice is hereby given that the above-named Order, made on the 6th August 1976, is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as an unopposed Order, by the Dacorum District Council.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way to a line running almost parallel to the existing path but will be moved a distance of between 5 and 3 yards east of its present line, 5 yards at Bury Rise end and 3 yards at the junction with Footpath No. 16.
