(c) limit waiting to a period of 1 hour in any period of 2 hours from 8 a.m. to 6 p.m. on Monday to Saturday inclusive in the lengths of roads specified in the Third Schedule to this notice;
(d) limit waiting to a period of 2 hours in any period of 4 hours from $8 \mathrm{a} . \mathrm{m}$. to $6 \mathrm{p} . \mathrm{m}$. on Monday to Saturday inclusive in the lengths of roads specified in the Fourth Schedule to this notice;
(e) limit waiting to a period of 2 hours in any period of 4 hours in the length of road specified in the Fifth Schedule to this notice;
(f) prohibit loading or unloading between the hours of $9.30 \mathrm{a} . \mathrm{m}$. and $11.30 \mathrm{a} . \mathrm{m}$. or $4 \mathrm{p} . \mathrm{m}$. and $6 \mathrm{p} . \mathrm{m}$. on Monday to Saturday inclusive in the lengths of roads specified in the Sixth Schedule to this notice;
(g) make it unlawful for any person to drive a vehicle into the length of road (known as a "boxed area") specified in the Seventh Schedule to this notice unless the vehicle can immediately thereafter be driven wholly out of the boxed area again.
Exceptions will be included in the Orders to permit picking up and setting down passengers, the maintenance of the roads and the services therein, to enable a vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the roads, and, except in the case of ( $f$ ) above, in respect of disabled drivers' vehicles and the loading and unloading of goods; and in the case of (g) above in respect of vehicles waiting to make a right-hand turn.
Copies of the draft Orders together with a statement of the County Council's reasons for proposing to make the Orders and a plan showing the lengths of roads concerned may be examined at my office between the hours of 9 a.m. and 4 p.m. on Monday to Friday inclusive and at the offices of the Uckfield Parish Council, Town Hall Chambers, Uckfield, during normal office hours until 17th September 1976.
