Whereas the South Derbyshire District Council (hereinafter called "the Council") is the district planning authority for the area.

And whereas, on 11th April 1973, the former Repton Rural District Council acting on behalf of the Derbyshire County Council and in pursuance of their powers under the Town and Country Planning Act, 1971 and under the Town and Country Planning General Development Orders 1963-1969 granted a planning permission (Reference No. REP/1172/6) (hereinafter called "the planning permission") to Mr. G. C. Cooke of 45 Alrewas Road, Kings Bromley, Burton-on-Trent for the erection of a bungalow, for Mrs. M. M. Staley, on land being part of O.S. field No. 8070, Calvescroft Farm, Rosliston and more particularly delineated in red on the plan annexed hereto (hereinafter called "the red land").

Details of the planning permission are set out in the Schedule hereto.

The building or other operations referred to in the planning permission have not been completed.

It appears to the Council that it is expedient having regard to the development plan and to all other material considerations that the planning permission should be revoked in the manner hereinafter appearing, since the red land has passed into new ownership and the new owner wishes to convert the existing coach house into a farm worker's dwelling rather than build the bungalow to which the planning permission relates. There is insufficient agricultural justification to necessitate two additional dwellings at the farm.

Now therefore in pursuance of the powers contained in section 45 of the Town and Country Planning Act, 1971 and all other powers them enabling the Council hereby Order as follows:

The planning permission is revoked.

The Order shall be cited as "The South Derbyshire District Council Revocation of Planning Permission Order No. 2 (1976)".
