# TOWN AND COUNTRY PLANNING ACT, 1971 Town and Country Planning General Development Orders, 1963-1969

In pursuance of the powers vested in the Derbyshire County Council under the above Act and Orders and delegated to this Council, and with reference to your appli-cation (Office Code No. REP/1172/6) submitted on the 2nd November 1972, for permission to erect a detached bunga-low, part of O.S. field No. 8070, Calvescroft Farm, Roslis-ton, for Mrs. M. M. Staley, in the manner described on the application and shown on the accompanying plan(s) and drawing(s).

Notice is hereby given that permission for the proposed development is granted subject to compliance with the following conditions:

Conditions

1. This permission is subject to the condition that the development must be begun not later than the expiration of five years from the date of the permission unless some other specific period has been indicated in other conditions given.

2. Notwithstanding the description of the materials in the application, no development shall be commenced until precise details of the materials to be used in the construc-tion of the external walls and roof of the building have been submitted to and approved by the Local Planning Authority.

3. The proposed garage shall be used for private and domestic purposes only, and no trade or business shall be carried on at the premises.

4. The proposed dwelling shall be sited in accordance with the amended site plan submitted by the applicant under cover of letter dated 26th February 1973 (copy attached).

5. The occupation of the dwelling shall be limited to persons whose employment is in agriculture, as defined by section 290 of the Town and Country Planning Act 1971, and including the dependents of such persons.

### **Reasons** for Conditions

1. The condition is imposed in accordance with section 4. 42 and 43 of the Town and Country Planning Act, 1971.

2. To enable the Local Planning Authority to retain control over the external appearance of the building in the interests of amenity.

3. In order that the amenities enjoyed by adjoining residential properties shall not be prejudiced.

4. In order that the Local Planning Authority shall retain control over the proposed development in the interests of rural amenity.

5. This area is not intended to be allocated for general development in the Development Plan, owing to its remote-ness from the services and facilities normally necessary to serve residential development and this consent is granted solely in the interests of agriculture.

Note. With regard to condition 2 above, the applicant is advised that the use of a red rustic facing brick and thin plain dark grey roofing tiles are more appropriate as the materials of construction in this locality.

Notice is hereby given that the above-named Order (herein-after referred to as "the Order") made on the 13th August 1976 is about to be submitted to the Secretary of State for the Department of the Environment for confirmation or to be confirmed by the District Council of North Dorset as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running from Point "A" to Point "D" on the plan attached to the Order to a line running from Point "A" to Point "B" and then from Point "C" to Point "D" shown on the and then from Point "C" to Point "D" shown on the said plan, such diversion representing a transfer of the footpath out of its present position approximately parallel to and on the south-east side of Towns Knapp Lane into a position running north-westward from the said Point "A" for about 30 metres to a point on Towns Knapp Lane iust north-east of its junction with Wood Lane (then north-eastwards for approximately 80 metres along Towns Knapp Lane this not being part of the Diversion Order) and then south-eastward for about 30 metres to rejoin Footpath No. 7 aforesaid.
