## THE SCHEDULE

1. To prohibit the waiting of any vehicle other than Stage Carriages and Scheduled Express Carriages between the hours of 7 a.m. and 7 p.m. on any day on the areas of the carriageway of Woodland Road, Darlington between its junction with Portland Place and its junction with Milbank Road marked with road marking shown in diagram 1025.1 in Schedule 2 to the Traffic Signs Regulations and General Directions 1975 (Bus stop marking) ("the authorised markings") unless the vehicle:
  - (a) is being used for removal of any obstruction to traffic; or
  - (b) is being used in the service of a local authority or of a water authority or with the permission of the Council in exercise of statutory powers or duties and whilst being so used it is necessary for the vehicle to wait in the place where it is waiting; or
  - (c) in any case where the person in control of the vehicle is required by law to stop, or is obliged to do so in order to avoid an accident, or is prevented from proceeding by circumstances outside his control; or
  - (d) is being used for police, re brigade or ambulance purposes.
2. Although the proposed Order includes every bus stop in the length of road specified above, it should be noted that the provisions of the Order which prohibit waiting will apply only to those bus stops which the Council marks with the authorised markings.
3. While the Order remains in force it enables the Council at any time to lay or to remove the authorised markings at or from any bus stop in the length of road specified above or to adjust the position in that road of the authorised markings as traffic conditions may require.

## NEWPORT BOROUGH COUNCIL

*The Newport Borough Council (Westfield Drive/Westfield Way) (Experimental Prohibition of Right Hand Turn) Order 1976*
