*The Greater Manchester County (Walmersley Road) (Bus Stops) (Clearway) (County) Order 1975*

Notice is hereby given that on the 17th August 1976, the Greater Manchester County Council made an Order under section 1 (1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit vehicles, other than buses, from waiting between 7 a.m. and 7 p.m. on any day at the bus stop in the length of road specified below where the carriageway at that stop is marked (a) as a bus stop, and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings"):

*Walmersley Road, Bury, west side, from Fox Street to a point 51 metres south thereof.*

It should be noted that the provisions of the Order which prohibit waiting will apply only to the bus stop which the Council marks with the authorised markings. While the Order remains in force it enables the Council at any time to lay or to remove the authorised markings at or from the bus stop in the specified road or to adjust the position in that road of the authorised markings, as traffic conditions may require.

Other vehicles will be permitted to wait at the bus stop with authorised markings, where necessary, for:

- (1) the removal of any obstruction to traffic;
- (2) the maintenance of the road and in exercise of statutory powers with permission of the Council; and
- (3) reasons of emergency.

The County Borough of Bury (Walmersley Road) (Restriction of Waiting) Order 1972 has been amended in so far as it was inconsistent with the above restriction.

A copy of the Order which will come into operation on the 8th November 1976 and a map showing the road to which it relates may be inspected between the hours of 9 a.m. and 4.30 p.m. on Mondays to Fridays at:

- (a) The County Secretary's Office, County Hall (Minshall Street entrance), Piccadilly Gardens, Manchester; and
- (b) The Director of Administration's Office, Town Hall, Bury.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirements of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from the 17th August 1976, apply to the High Court for this purpose.

*The Greater Manchester County Council (Milkstone Road, Rochdale) (One-Way Traffic) (County) Order 1976*

Notice is hereby given that the Greater Manchester County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to impose one-way traffic working on:

*Milkstone Road, between Drake Street and Tweedale Street in a southerly direction.*

A copy of the proposed Order and a map showing the road to which it relates together with a statement of the Council's reasons for proposing to make the Order may be inspected at:

MIDDLESBROUGH BOROUGH COUNCIL

*The Middlesbrough Borough Council (Restriction of Waiting) (Various Roads) (No. 6) Order 1976*

Notice is hereby given that Middlesbrough Borough Council acting as agent for the Highway Authority Cleveland County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Cleveland County Constabulary.

The effect of the Order will be to prohibit the waiting of vehicles in certain lengths and sides of roads in Middlesbrough for road safety reasons.

- (a) *No waiting at anytime on any day.*

*Unnamed Road, which links the eastern part of Southfield Lane with Southfield Road, west side.*

*Unnamed Road, which links the western part of Southfield Lane with Southfield Road, east side.*

*Southfield Lane, north side, from its junction with Linthorpe Road a distance of 135 metres in an easterly direction.*

*Southfield Road, north side, from a point 80 metres east of its junction with Linthorpe Road for a distance of 20 metres in an easterly direction.*

*Parliament Road, west side, between Union Street and a point 65 metres west of the Union Street western kerbline and for 30 metres west from a point 180 metres west of the Union Street western kerbline.*

*Fry Street, north side, for a distance of 35 metres eastwards from the eastern kerbline of Gurney Street.*

*Fry Street, south side, for a distance of 130 metres in an easterly direction from the eastern kerbline of Gurney Street.*

- (b) *No waiting Monday to Saturday between 8 a.m. and 6 p.m.*

*Fry Street, north side, for 80 metres westwards from the south-west kerbline of Marton Road.*

*Fry Street, south side, from a point 130 metres eastwards from the eastern kerbline of Gurney Street to the south west kerbline of Marton Road.*

The Order will revoke certain waiting restrictions in Parliament Road, Fry Street, Elm Street and Southfield Lane.

There are certain exemptions to the Order in favour of statutory undertakers and others carrying out works, emergency service vehicles, persons engaged in loading and unloading, and disabled persons vehicles.
