TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (County of South Yorkshire) (Sheffield No. 9) Order 1976" authorising the stopping up of lengths of Creswick Street and Primrose Hill at Langsett, Sheffield.
