If the provisions of the Order continue in operation for a period of not less than 12 months and have not at any time been varied under section 9 of the Act of 1967, the Council will consider in due course whether the provisions of the Order should be reproduced and continued in force indefinitely by means of an Order under section 6 of the said Act of 1967. Any person desiring to object to the making of the Order under section 6 of the said Act of 1967 for the purpose of such reproduction and continuation in force may, within the aforementioned period of 12 months send a statement in writing of his objection and the grounds thereof to the Director of Planning and Transportation, The County Hall, London, SE1 7PB, quoting the reference PT/TD/LS.

## GREATER LONDON COUNCIL

### LONDON BOROUGH OF WALTHAM FOREST

#### *The Waltham Forest (Waiting and Loading Restriction) (Amendment No. 13) Order 1976*

Notice is hereby given that the Greater London Council on 20th August 1976 made the above-mentioned Order under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Order will be further to amend the Waltham Forest (Waiting and Loading Restriction) Order 1972,

(A) so that the existing prohibition on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) which applies in the length of Hainault Road specified in Schedule 1 to this notice and in the first 60 feet of adjacent King Edward Road will also apply between 8 a.m. and 8.30 a.m. on Mondays to Saturdays inclusive;

(B) to create an urban clearway on those parts of the main routes A.112 and A.1006 specified in Schedule 2 to this notice so that:

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited:

(i) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in the lengths of streets specified in Schedule 3 to this Notice and in the first 60 feet of adjacent streets specified in Schedule 4 to this notice;

(ii) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in the length of streets specified in Schedule 5 to this notice;

(b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle will be prohibited:

(i) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Monday to Fridays inclusive in the street and length of streets specified in Schedule 6 to this notice;

(ii) unless otherwise prohibited, for a period of more than 20 minutes in the same place during the times when the prohibition on waiting by vehicles (otherwise than for the purpose of delivering or collect-

ing goods or loading or unloading a vehicle) applies or will apply in the streets and length of streets specified in Schedule 2 to this notice;

(c) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in sub-paragraph (B) (a) above will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Waltham Forest Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purposes of advertising, in the lengths of streets referred to in sub-paragraph (B) (a) above will be prohibited;

(e) any existing prohibitions on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle in the street and lengths of streets referred to in sub-paragraph (B) (b) (i) above imposed by the Waltham Forest (Waiting and Loading Restriction) Order 1972 will be revoked.

3. The prohibitions referred to in paragraph 2 (B) (a) and (b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from road-side petrol stations; to licenced street traders, etc.

4. A copy of the Order, which will come into operation on 31st August 1976 and of the Waltham Forest (Waiting and Loading Restriction) Order 1972 (and of the Orders which have previously amended that Order) can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Order was made in Room B.21, The County Hall, London, SE1 7PB.
