delivered at premises adjacent to the vehicle from which the sale is effected;

(d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, will be prohibited.

3. The prohibitions referred to in paragraph 2 (a) and (b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The

side petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" will apply. 4. Notice is hereby given that the Greater London Council on 20th August 1976 made the above-mentioned Orders under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968, and the Road Traffic Act 1974. 2. The effect of the Merton (Prescribed Routes) (No. 6) Traffic Order 1976 will be in the London Borough of Macton

Merton.

(a) to compel the left turn for vehicular traffic

(i) entering London Road, Morden from the un-named access road lying immediately south-west of No. 64 London Road, Morden ;

(ii) from Aberconway Road into London Road, Morden ;

- (b) to prohibit the U-turn from the north-western carriageway of London Road, Morden into the south-eastern carriageway of that road at the north-eastern end of the central reservation at a point 20 feet north-east of the party wall of Nos. 55 and 57 London Road, Morden;
- (c) to prohibit vehicles proceeding in the south-eastern carriageway of London Road, Morden from entering the gap in the Aberconway Road ; central reservation lying opposite
- (d) to prohibit all vehicles except buses proceeding in the south-eastern carriageway of London Road, Morden from entering the carriageway between the central reser-

vation and the island site situated at or adjacent to the junction of Crown Lane and London Road, Morden;

(c) to impose one-way working for vehicular traffic in

(i) Crown Lane, between Crown Road and London Road, Morden, from west to east;
(ii) Crown Road, from south-east to north-west;

3. The general effect of the Merton (Waiting and Load-ing Restriction) (Amendment No. 16) Order 1976 will be further to amend the Merton (Waiting and Loading Restriction) Order 1971 so that, in the London Borough of Merton,

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unload-ing a vehicle) will be prohibited

(i) during the time between 8 a.m. and 6.30 p.m. on Mondays to Saturdays, inclusive, in the lengths of streets specified in Schedule 1 to this notice ;

(ii) during the time between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays, inclusive, in the length of street specified in Schedule 2 to this notice;
(b) waiting by vehicles for the purpose of delivering or building of the street specified of

collecting goods or loading or unloading a vehicle will be prohibited.

(i) during the time between 8 a.m. and 6.30 p.m. on Mondays to Saturdays, inclusive, in the lengths of streets specified in Schedule 3 to this notice;

(ii) during the time between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays, inclusive, in the lengths of streets specified in Schedule 4 to this notice;

(iii) unless otherwise prohibited as above, for a period of more than 20 minutes in the same place during the time between:

- (1) 11 a.m. and 6.30 p.m. on Mondays to Saturdays, inclusive, in the lengths of streets specified in Schedule 1 to this notice ;
- (2) 4.30 p.m. and 6.30 p.m. on Mondays to Fridays,
- (2) 4.30 p.m. and 0.30 p.m. on Mondays to Fridays, inclusive, in the lengths of streets specified in Schedule 2 to this notice;
 (c) the sale or offer for sale of goods from a vehicle in the lengths of streets referred to in paragraph 3 (a) above will be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Council of the London Borough of Merton or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected : to the vehicle from which the sale is effected ;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the lengths of streets referred to in paragraph 3(a) above will be prohibited.

4. Any existing prohibitions on waiting by vehicles (in-cluding waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle), on the sale of goods and on advertising activities

(a) in the lengths of streets referred to in paragraphs 3(a) and (b) above; and (b) in the lengths of streets specified in Schedule 5 to

this Notice will be revoked.

5. The prohibitions referred to in paragraph 4 above will not apply in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled per-son's "Orange Badge" will apply.
