GOSPORT BOROUGH COUNCIL

The Borough of Gosport (Prohibition of Waiting) (No. 5) Order 1976

Notice is hereby given that on the 27th August 1976 the Gosport Borough Council as Agents for the Hampshire County Council made an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to extend the existing Prohibition of Waiting at the western end of Portsmouth Road, Lee-on-the-Solent, to clear the rear accessway adjacent to No. 192.

The Order which comes into operation on the 1st September 1976 contains provisions for the usual exemptions to permit waiting by disabled persons, registered medical practitioners, midwives and district nurses in the course of their professional duties; for boarding or alighting; for the loading and unloading of goods; for funerals; for building operations and work in connection with public services.

A copy of the Order, together with a map showing the restricted area concerned may be examined in my Department at the Town Hall, High Street, Gosport, from Monday to Friday between 9 a.m. and 1 p.m. and 2 p.m. and 5 p.m.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974 or on the grounds that any requirements of that Act or any instrument made under it has not been complied with in relation to the Order you may, within 6 weeks from the 27th August 1976 apply to the High Court for this purpose.

HAMPSHIRE COUNTY COUNCIL

ROAD TRAFFIC REGULATION ACT, 1967

The Hampshire (Burnett Close, Ruffield Close and Godwin Close, Winchester) (30 m.p.h. Speed Limit) Order, 1976

Notice is hereby given that the Hampshire County Council have on the 17th August 1976 made an Order in exercise of their powers under section 74 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968 and Schedule 19 to the Local Government Act, 1972 and of all other powers then enabling in that behalf and after consultation with the Chief Officer of Police for Hampshire, the effect of which is to impose a 30 miles per hour speed limit on the lengths of road specified in the Schedule to this notice.

A copy of the Order and a plan showing the lengths of road in question, may be inspected at the office of the Winchester City Council, Colebrook Street, Winchester and at the office of the undersigned during usual office hours.

The Order will come into operation on the 1st September 1976.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the grounds that it is not within the powers of section 74 of the Road Traffic Regulation Act, 1967, or on the grounds that any requirement of that section or of section 84A, 84B or 84C of the Act or any regulations made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks from the date that the Order was made, make application for the purpose to the High Court.

HARLOW DISTRICT COUNCIL

The District of Harlow (Town Centre) (Various Roads) (Prohibition of Driving and Restriction of Waiting) Order 1976.

Notice is hereby given that the Harlow District Council propose to make an Order under section 1 (1), (2), (3) and (6) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

When this Order comes into effect you will not be allowed to:

- (i) drive any vehicle along West Gate from a point 86 metres east of its junction with Linkway north and westwards for a distance of 167 metres;
- (ii) drive any vehicle along East Gate from a point 62 metres from its junction with Terminus Street for a distance of 15 metres;
- (iii) drive any vehicle along North Gate from a point 78.5 metres from Post Office Road for a distance southwards of 15.5 metres.

On the following roads no waiting and no loading will be allowed between the hours of 8 a.m. and 8 p.m. from Mondays to Saturdays:

Northgate (West Side)

From its junction with Fourth Avenue south for the complete length to its junction with Linkway.

From its junction with Linkway south for the complete length including the turning bay.

Northgate (East Side)

From its junction with Post Office Road south for a distance of 13 metres.

From a point 44.5 metres south of Post Office Road south for a distance of 11.7 metres.

Eastgate. From the junction with Post Office Road on the north side westwards for its entire length.

Eastgate. From the junction with Terminus Street on the south side, westwards for the entire length to the service road between Nos. 29 and 31 Eastgate.

On the following lengths of roads no waiting will be allowed between 8 a.m. and 8 p.m. Mondays to Saturdays:

Linkway (Aylmer House lay-by). From a point 30 metres west from its junction with Northgate on the south side, westwards for a distance of 27 metres.
