*Proposed Stopping Up of a Length of Highway in the Parish of Bishopstone*

Notice is hereby given, that the Wiltshire County Council intend to make application to the Magistrates' Court sitting at The Guildhall, Market Square, Salisbury, in the said county at 10.30 a.m. on Monday, 18th October 1976, for an Order under section 108 of the Highways Act 1959, authorising the stopping up of a length of highway in the Parish of Bishopstone as follows:

That length of unclassified road running south of the River Ebble from the unclassified road (12045) Crouchston to Bishopstone Road eastwards across the Old Three Horseshoes Bridge to its junction with the unclassified road (12045) Broad Chalke to Bishopstone Road,

subject to the reservation of a bridleway over the whole length.

The application is being made on the grounds that the highway is unnecessary for public use other than as a bridleway.

A copy of the plan showing the effect of the Order applied for may be inspected free of charge during normal office hours at the County Solicitor and Clerk's Department (Environment Division), County Hall, Trowbridge, and at the offices of the Salisbury District Council, Bourne Hill, Salisbury.

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER  
HIGHWAYS ACT 1959

*The West Yorkshire Metropolitan County Council (Rothwell No. 26) Public Path Diversion Order 1976*

Notice is hereby given, that on 17th August 1976, the West Yorkshire Metropolitan County Council confirmed the above-mentioned Order.

The effect of the Order, as confirmed, is to divert the public right of way running from a point approximately 120 yards south-west of Woodside View at 3286 2548 in a south-westerly, south-easterly and south-westerly direction for a distance of approximately 540 yards to 3272 2517 at Lingwell Gate Beck to a line directly joining the two points previously mentioned, the new line of path having a length of approximately 380 yards.

A copy of the confirmed Order, and the map contained in it, has been deposited at Room 226, County Hall, Wakefield, and at the Leeds City Council Offices, Civic Buildings, Rothwell, Leeds, and may be there inspected free of charge during office hours, Mondays to Fridays.

The Order becomes operative as from 27th August 1976 but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order he may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 27th August 1976, make application for the purpose to the High Court.

## LOOE HARBOUR

*Re: Application for Revision Order*

Notice is hereby given, that the Commissioners of the Harbour of Looe in the county of Cornwall have applied to the Minister of Agriculture, Fisheries and Food for an Order whereby, for the purposes of meeting their obligations and discharging their functions in the future and subject to the terms, conditions and limitations set out in the draft Order hereinafter referred to, they will be enabled:

1. To borrow from time to time, upon the security of all or any revenues and property belonging to them and by any method or methods they see fit, such sums of money as they may think necessary not exceeding in aggregate £50,000, and with the consent of the Minister of Agriculture, Fisheries and Food such further sums of money as they may require.
2. To borrow temporarily, by way of overdraft or otherwise, such sums as they may require for meeting their obligations of discharging their functions under or in pursuance of any enactment, provided that the total amount outstanding at any one time of the money so borrowed shall not exceed £7,500.
