The QUEEN has been graciously pleased to give and grant unto the Institute of Purchasing and Supply Her Majesty's Royal Licence and Authority that it may bear and use in its corporate capacity on Seals or otherwise according to the Laws of Arms certain Armorial Ensigns which were granted and assigned by Letters Patent dated 20th January 1959 under the hands and Seals of Garter, Clarenceux and Norroy Kings of Arms, comprising Arms, Crest, Supporters and a Badge, to the Purchasing Officers Association; the said Armorial Ensigns to be first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.
