DEPARTMENT OF THE ENVIRONMENT

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of East Sussex) (No. 4) Order 1976" authorising the stopping up of part of Ingram Crescent, Hove, Sussex.

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make the following Orders:

- (1) An Order under section 209 of the above Act to authorise the stopping up of a part of Bunyan Road, Bedford, to enable residential development consisting of the construction of sixteen flats to be carried out by North Bedfordshire Borough Council.
