EAST STAFFORDSHIRE DISTRICT COUNCIL

CONTROL OF POLLUTION ACT 1974

The East Staffordshire District Council No. 1 Noise Abatement Order 1976

Notice is hereby given that the East Staffordshire District Council (hereinafter called "the Council"), in exercise of the powers conferred on them by section 63 of the Control of Pollution Act 1974, on the 6th July 1976 made an Order entitled "The East Staffordshire District Council No. 1 Noise Abatement Order 1976" declaring the area described in the Schedule hereto to be a Noise Abatement Zone, which is about to be submitted to the Secretary of State for the Environment for confirmation.

The primary purpose of the Order is the long-term control of noise from fixed installations described in the Schedule hereto. The Order having been confirmed, the Council is then required to measure the noise emanating from the classified premises and to keep a public register of the recorded levels. These levels then become the maximum which may emanate from these premises and except by the written consent of the Council, it will be an offence for them to be exceeded.

If confirmed the Order will come into force 3 months from the date of confirmation by the Secretary of State for the Environment.

Copies of the Order and the map referred to therein may be inspected free of charge at Room 41, Department of Environmental Health, Town Hall, Burton upon Trent at all reasonable hours during the period of 6 weeks from the 3rd September 1976.
