TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of that length of highway described in the Schedule below to enable development to be carried out in accordance with planning permission granted under Part III of that Act.

The Order requires the provision of new highways maintainable at the public expense for which the highway authority is to be the Mid Glamorgan County Council.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office (Y Swyddfa Gymreig), Transport and Highways Group, Gov-

ernment Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting the reference WR15/52/3) and may be inspected at all reasonable hours at the offices of the Merthyr Tydfil Borough Council, Town Hall, Merthyr Tydfil.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder have not been complied with in relation to the Order, may, within 6 weeks of the 2nd September apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The length of highway to be stopped up is in the Borough of Merthyr Tydfil in the County of Mid Glamorgan and is that length of highway known as Winchfawr Road which extends from a point 212 yards south-west of its junction with Thornbury Close in a south-westerly direction for a distance of 98 yards.
