WATER ACTS

THAMES WATER AUTHORITY DROUGHT ACT, 1976

Notice is hereby given that because of an exceptional shortage of rain the Thames Water Authority are applying to the Secretary of State for the Environment for an order (lasting for six months) under sections 1 and 3 of the Drought Act 1976.

The general effect of the Order would be to authorise the Authority:

- (a) Notwithstanding anything contained in section 162 of the Thames Conservancy Act, 1932, and Licence Number 28/39/M/2 and Variation (No. 1) of that Licence granted by the Conservators of the River Thames under the Water Resources Act, 1963, and in particular any restriction or obligation relating to flow of water over Penton Hook and Teddington Weirs, to take not exceeding 1,200 million gallons of water per day from the River Thames by means of any one or more of the intakes specified in the said Licence Number 28/39/M/2.
- (b) To take water from the said river at a point downstream of Molesey Weir and at a point downstream of Teddington Weir such point being in either case within 100 metres of any point of the relevant weir a quantity of water in each case not exceeding 50 mgd and to discharge the water so taken upstream of Molesey and Teddington Weirs respectively.

(c) To take and discharge water under the foregoing paragraph by means of engines, pumps, machinery, pipes and other necessary or convenient works.
