CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT 1952

To:—Rollend Material Nederland B.V.,
Europaleen 33,
Utrecht, Holland.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely: one trailer UC 12/8 imported into the United Kingdom as a temporarily imported trailer under a TPN entry dated 12th May 1975, have been seized as liable to forfeiture upon the grounds that:

- (a) on or about 12th May 1975, the said trailer, being imported goods chargeable with a duty of customs, was without payment of that duty removed from its place of importation;
- (b) in relation to the said trailer, a document, namely a customs general undertaking dated 28th April 1975, being a document produced for the purposes of an assigned matter, namely customs, was recklessly delivered to an officer and the said document was untrue in a material particular in that it stated that the said trailer was owned and operated by a person whose principal place of business was outside the United Kingdom which was not the true case.

Whereby and by force of sections 44 and 301 of the Customs and Excise Act 1952 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
