### PRIVY COUNCIL OFFICE

#### UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

Statutes made by the Governing Body of Exeter College, in the University of Oxford, on the 26th October 1976, have been submitted for the approval of Her Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The QUEEN'S Most Excellent Majesty in Council

Whereas a Representation duly made to Her Majesty in Council by the Secretary of State for the Environment that burials should be discontinued as hereinafter directed in the old part of St. Mary with St. Stephen's Churchyard, Wolsingham, in the County of Durham, has in pursuance of an Order in Council made the 30th day of July 1976, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853 (1853 c. 134), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith in the old part of St. Mary with St. Stephen's Churchyard, Wolsingham, in the County of Durham, shown hatched on the plan annexed hereto.

Provided that—

(a) in the one remaining earthen grave now existing in the said part of the Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave, and

(b) in the said part of the Churchyard, in the one grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of the family for which such space has been reserved and appropriated as a burial place, with the exclusive right of burial therein,
