 (2) to protect all trees within Conservation Areas from any act which would be prohibited by a Tree Preserva-tion Order.

Within the designated area no building other than any such building as is referred to in the direction made by the Secretary of State for the Environment in paragraph 15 of Circular 174/74 may be demolished without the prior written consent of the Local Planning Authority, as though it were a building contained in the list of buildings of special architectural or historic interest prepared by the Secretary of State

In addition trees within the Conservation Area may not be loped, topped, felled, uprotted or wilfully damaged or destroyed unless notice of the proposed action has been destroyed unless notice of the proposed action has been given to the Local Planning Authority and written per-mission to proceed has been received, or the authority has failed to take any conclusive action regarding the notice within 6 weeks from the date of service. There are certain exceptions to this rule, in general terms, these cover trees subject to the exemption already contained in the Second Schedule to the Form of Tree Preservation Orders and trees not exceeding 75 millimetres (approximately 3 inches) in diameter (or 100 millimetres where the growth of other trees would be improved by forestry operations). Trees trees would be improved by forestry operations). Trees already included in Tree Preservation Orders are not subject to the above procedure but are subject instead to the more stringent requirements of the Order concerned.

Copies of the map showing the exact boundaries of the extension to the Baldock Conservation Area have been deposited at the District Council Planning Office, Gernon Road, Letchworth, Hertfordshire, and also at the County

Baldock Conservation Area has been extended in three parts:

- (1) To the north, starting on the existing boundary in Pond Lane, some 45 metres west of Church Street it runs northwards following the rear boundaries of the properties fronting the west side of Church Street, to the north side of Icknield Way, turning eastwards along Icknield Way to a point 15 mertes east of Church Street. It returns south running parallel with Church Street to the rear of 52 Church Street, turning east, encompassing the building to the rear of 50 Church Street, as far as the footpath linking Icknield Way with Meeting House Lane, which it follows south Way with Meeting House Lane, which it follows south as far as Meeting House Lane. It turns castwards along the lane for a distance of 25 metres then turns south-east to Orchard Road, following the west boun-dary of 5A Orchard Road, the northern edge of Orchard Road for a distance of 14 metres, and then turning southwards along the west boundary of 8 Orchard Road, up to the existing boundary of the Conservation Area.

Following this boundary, it then turns northwards along the western boundaries of the pro-perties fronting Park Street, continuing along the western edge of the Park Street and following it round in a westerly direction for 20 metres where it crosses Park Street and meets the existing boundary of the Conservation Area to the rear of 30-31A Hitchin Street.
