of approximately 170 metres.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, the laying, erection, alteration or repair of any gas, water or electricity or telegraph line, a vehicle being used in the service of a local authority or water authority in pursuance of statutory powers or duties, the delivery or collection of postal matters are whisled to take in partial of the service of th collection of postal packets, a vehicle to take in petrol, oil, water or air and a vehicle being used for police, fire brigade or ambulance purposes.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 7th January 1977, apply to the High Court for the suspension or quashing of the

order or of any provision contained therein.

The Trunk Road (Marlborough) (Bus Stops) (Clearway) Order 1977

The Secretary of State for Transport proposes to make an Order under section 1 (1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974 on the London-Bristol Trunk Road (A4) at Marlborough in the District of Kennet in the County of Wiltshire.

The effect of the Order will be to prohibit vehicles, other than buses, from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in that length of High Street, Marlborough which extends from its junction with Hyde Road to its junction with New Road where the carriageway at that stop is marked (a) as a bus stop and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

Although the Order includes every bus stop in the length

of road specified above, it should be noted that the provisions of the Order which prohibit waiting will apply only to those bus stops which are marked with the authorised

markings.

While the Order remains in force it enables the Secretary of State at any time to lay or to remove the authorised markings at or from any bus stop in the length of road specified above or to adjust the position in that road of the authorised markings, as traffic conditions may require. The prohibition imposed by the Order will not apply:—

(a) to a vehicle being used in connection with the removal

of any obstruction to traffic;
(b) to a vehicle being used by, or with the permission of a local authority in exercise of statutory powers or duties:
