

The Order will come into operation on 10th January 1977 and the effect of it will be to prohibit the parking of vehicles at all times in The Upway, Basildon for a distance of 40 metres on its eastern side from its junction with Whitmore Way.

A copy of the Order and a map showing the area affected by it are available at the Council Offices, Fodderwick, Basildon, where they may be examined at all reasonable hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from 7th January 1977, apply to the High Court for this purpose.

#### BLACKBURN BOROUGH COUNCIL

*The Borough of Blackburn (Walter Street) (Experimental Prohibition of Waiting) Order 1976*

Walter Street, north side, from its junction with Lambeth Street to its junction with Lincoln Road.

Walter Street, south side, from its junction with Lambeth Street for a distance of 13 metres in an easterly direction. (772)
