- (f) provide that the vehicles which may be left in the parking places would be passenger vehicles (12 seats or less), goods carrying vehicles, motor cycles and invalid carriages;
- (g) provide that any unexpired time shown on a parking meter may be used free of charge and the period during which a vehicle may not return to a parking place would be one hour; and
- (h) provide that certain vehicles may wait free of charge in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes) and vehicles left by specified disabled persons (no time limit).
- 4. The restrictions imposed by the Hackney (Waiting and Loading Restrictions) Order 1972, would apply to any areas previously designated as parking places and not redesignated as such, as they apply in the immediate vicinity.
- 5.
