

Conservation Area, the character or appearance of which it is desirable to preserve or enhance.

The effects of designating an area as a Conservation Area are as follows:

1. Any building within a Conservation Area other than a listed building (except a building referred to in section 58 (2) of the Act, or a building excepted by the Secretary of State) must not be demolished without the consent of the City Council.
2. Advertisements in Conservation Areas may be controlled by the City Council to avoid detracting from the appearance of the areas.
3. Trees in Conservation Areas are protected by the Act against felling, topping, lopping, uprooting and wilful damage.

Plans of the Conservation Area may be seen at the office of the City Planning Officer, The Guildhall, North Church Street, Nottingham. The area which has been designated is as follows:

#### *Wollaton Park Conservation Area Boundary*

The southern boundary of Wollaton Park Conservation Area runs along the boundary fence at the rear gardens of Nos. 598-612 Adams Hill. At the north-west corner of the plot of No. 612 Adams Hill the boundary follows the western edge of the aforementioned plot until it reaches the northern boundary of Derby Road. At this point, the boundary extends westward and continues in this direction along the boundary wall on the northern side of Derby Road.

At the eastern boundary of "Beecholme" the Conservation Area Boundary turns and continues in a north-westerly direction following the boundary at the rear of Nos. 8-34 Wollaton Vale and 2-120 Parkside. At the rear of 120 Parkside the boundary runs north-west to include the playing field at the rear of Nos. 122-136 Parkside. The boundary includes an access to the playing field which runs between the house named "Blair" and 55 Bramcote Lane. The boundary continues in a north-easterly direction running at the rear of Nos. 55-27 Bramcote Lane.

At the junction of the southern and eastern boundaries of No. 27 Bramcote Lane, the boundary extends south-eastwards for a distance of approximately 65 metres where it then turns to run in a north-easterly direction to meet the south-western boundary of the Hirst Crescent Development. It continues along this south-western boundary and the south-eastern boundary of Hirst Crescent to Wollaton Road, thereafter extending along Wollaton Road in a north-easterly direction.

At the Police Station on Wollaton Road the boundary follows the western and southern boundaries of this site and then turns south-east to run along the rear of Nos. 2-24 Cambridge Road. Here the boundary turns eastwards along the southern boundary of No. 24 Cambridge Road and the rear of Nos. 195-107 Harrow Road where it then turns northwards for a short distance. It then follows the back edge of the pavement of Harrow Road between Nos. 107 and 87 before returning in a south-westerly direction along the boundary separating Wollaton Park from the Glenn Bott Secondary School playing field. The Conservation Area Boundary then follows the south-western boundary of the school site until it abuts Sutton Passeys Crescent.

Here the Park Boundary turns southwards and follows the south-western side of Sutton Passeys Crescent until it reaches the western boundary of No. 41 Sutton Passeys Crescent. The boundary then runs southwards before turning east to run at the rear of Nos. 41-1 Sutton Passeys Crescent. At the rear of No. 1 the boundary turns to include the width of Lime Tree Avenue before returning in a westerly direction along the rear of properties off Coombe Close, Lanark Close, Baildon Close and Oundle Drive. "The Thatch" situated off Baildon Close forms the western extent of this line. The line then turns and runs southwards following the rear of properties off Baildon Close and running along the boundary of No. 33 Oundle Close to join with the boundary first described.

##### NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

##### TOWN AND COUNTRY PLANNING ACT 1971—SECTION 210

##### *The City of Sheffield (Ecclesfield Nos. 29 and 32) Public Path Diversion Order 1976*

Notice is hereby given that on the 5th January 1977 the Sheffield City Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public rights of way over parts of footpaths 29 and 32 at Burncross as follows:

*No. 29*—From a line commencing at a point marked "A" on the map 175 yards north of Burncross Road and extending for a distance of 22 yards in a northerly direction to a point marked "B" on the map to a line commencing at the said point "A" and extending for a distance of 5 yards in an easterly direction and thence for a distance of 25 yards in a northerly direction to the said point marked "B" on the map.

*No. 32*—From a line commencing at a point marked "C" on the map on the east side of Blackburn Drive opposite its junction with Charlton Brook Crescent and extending for a distance of 87 yards in an easterly direction to a point marked "E" on the map to a line commencing at a point marked "D" on the map on the east side of Blackburn Drive 8 yards north of point "C" and extending for a distance of 100 yards in a general easterly direction to the said point marked "E" on the map.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Administration and Legal Department, Carmel House, 49 Fargate, Sheffield, between the hours of 8.45 a.m. and 4.45 p.m. on Mondays to Fridays.

This Order becomes operative as from the 7th January 1977, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act, 1971, within six weeks of the 7th January 1977 make application for the purpose to the High Court.

##### TOWN AND COUNTRY PLANNING ACT 1971—SECTION 210

##### *The Staffordshire Moorlands District (Footpath No. 26 Waterhouses) Public Path Diversion Order 1976*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 5th November 1976 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Staffordshire Moorlands District Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert part of Footpath No. 26 in the Parish of Waterhouses from a point at the northern boundary of field 8162 taking a south-westerly route for 50 feet and then in a southerly direction for 200 feet. The path then goes south-easterly for 50 feet until it rejoins the existing path at the southern boundary of field 8162.
