Notice is hereby given that the County Council of Mid Glamorgan propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be (i) to prohibit the waiting of vehicles for 24 hours per day, 7 days per week on the lengths of roads described in the Schedule to this notice (ii) to prohibit the waiting of vehicles from 8.30 a.m. to 9.30 a.m. and 3 p.m. to 4.30 p.m. Monday to Friday inclusive on both sides of Greenfield Terrace, North Cornelly, from a point opposite the southwestern side of its junction with the lane at the rear of No. 37 Heol Fach to a point opposite the south-western limit of the school premises a distance of approximately 78 metres (85 yards) (iii) to prohibit the waiting of vehicles from 8 a.m. to 6 p.m. Monday to Friday inclusive on the south-eastern side of Greenfield Terrace, North Cornelly from the south-western side of the school premises to its junction with Heol-y-Parc, a distance of Notice is hereby given that the County Council of Mid mises to its junction with Heol-y-Parc, a distance of approximately 142 metres (158 yards).

Exemptions will be provided in the Order for the purposes

of boarding, alighting, loading and unloading, building and road works, the maintenance of essential services, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled Persons vehicles in the service of the Post Office. Disabled Persons vehicles displaying the relevant disabled persons badge will be allowed to wait for up to 2 hours with return prohibited within 1 hour in respect of (i) and (iii) above and will be allowed to wait for a whole of the period of prohibition

in respect of (ii) above.

## WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (New Road, Shewen) (Prohibition of Waiting and 'Bus Stops Clearway) Order,

Notice is hereby given that the West Glamorgan County Council propose to make an Order under section 1 (1), (2), (3), (3B) and (6) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act, 1972, and Schedule 6 of the Road Traffic Act, 1974, the effect of which will be as follows:

- 1. To prohibit vehicles, other than 'buses, from waiting between 7 a.m. and 7 p.m. on any day at:
  - (a) the bus lay-by on the north side of New Road, Skewen, opposite the Colliers Arms Public House for a length of 42 metres from the western end and
  - (b) the 'bus lay-by on the south side of New Road, outside the Colliers Arms Public House for a length of 29 metres from the western end.
- To limit waiting to 1 hour, no return within 2 hours on the remaining lengths of the above lay-bys between
- the hours of 8 a.m. and 6 p.m., Monday to Saturday. To prohibit waiting at all times on the north side of New Road opposite the junction with Bethlehem Road (a length between Nos. 35 and 41 New Road).
- To prohibit waiting from 8 a.m. to 4 p.m., Monday to Friday on both sides of New Road between its junction with Grove Lane and Picton Terrace.

Exemptions will be provided in the Order for essential services, loading and unloading facilities, and disabled drivers' vehicles etc.
