

## NORTH YORKSHIRE COUNTY COUNCIL

*North Yorkshire County Council (Northallerton Road, Brompton) (De-restriction) Order, 1977*

Notice is hereby given that on the 11th January 1977 the Council of the County of North Yorkshire in exercise of their powers under sections 72 (3) and 73 (1) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972, and Schedule 6 to the Road Traffic Act, 1974, have made an Order, the effect of which is to revoke that part of the County Council of the North Riding of Yorkshire (Built-Up Area) Order, 1935, No. 2, which refers to that length of the Northallerton-Brompton County Road C.4 from a point 200 metres north of its junction with Stokesley Road to a point 56 metres south of its junction with De Bruce Road.

A copy of the Order which will come into operation on 18th January 1977 together with a map showing the lengths of road concerned may be examined at County Hall, Northallerton during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 11th January 1977 apply to the High Court for this purpose.—Dated 14th January 1977.

*North Yorkshire County Council (Market Place, Settle) (Restriction of Waiting) Order, 1977*

Notice is hereby given that on the 11th January 1977 the Council of the County of North Yorkshire in exercise of their powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act, 1974, have made an Order, the effect of which is to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day of the week on each side of the carriageway of the unadopted highway on the eastern side of Market Place, Settle, to the rear of the building known as The Shambles from its junction with Constitution Hill Unclassified County Road to its junction with the Settle—Kirkby Malham Class III County Road C.390 at the south-eastern corner of the Market Place.

A copy of the Order which will come into operation on 18th January 1977 together with a map showing the lengths of road concerned may be examined at the Police Station, Settle and at County Hall, Northallerton during normal office hours.

*The South Yorkshire County Council (Kimberworth Road and Ferham Road, Rotherham) (Prohibition of Waiting) Order, 1977*

Notice is hereby given that the South Yorkshire County Council propose to make an Order under section 1 (1), (2), and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974.

The effect of the proposed Order will be to prohibit waiting by vehicles at any time in any of the lengths of road or on any side of the roads specified in the Schedule to this notice.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein, in pursuance of statutory powers or duties and for the collection and delivery of postal packets.

A further exception will permit waiting by a vehicle which displays the relevant disabled persons' badges for a period of up to 2 hours, return prohibited within 1 hour.
