PUBLIC PATH DIVERSION ORDER

Northavon District Council (LCF 25 Frampton Cotterell)
Public Path Diversion Order, 1976

Notice is hereby given that on the 12th January 1977 the Northavon District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert part of the existing right of way running between Mill Lane and Frampton End Road, Frampton Cotterell from a point approximately 176 metres from its junction with Mill Lane to a point in an easterly direction approximately 250 metres from its junction with Frampton End Road and to create an alternative highway in lieu from the said point 176 metres from Mill Lane to proceed in a northerly direction for a distance of approximately 104 metres thence in a south-easterly direction for a distance of approximately 176 metres to reconnect with the remaining length of the existing footpath LCF 25.

The Order becomes operative as from the 12th January 1977 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highway Act, 1959 or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of this Order, he may under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from the date of this notice make application for that purpose to the High Court.

West Sussex County Council (Slinfold) Public Path (No. 1456/1) Extinguishment Order, 1976

Notice is hereby given that the above-named Order, made on 21st December 1976 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed, as an unopposed Order, by the West Sussex County Council.

The effect of the Order, if confirmed without modification, will be to extinguish the public footpath (Path No. 1456/1) in the parish of Slinfold, commencing at its junction with the maintainable highway, at a point approximately 230 feet south west of the disused railway line, (now dedicated as a public bridleway), extending generally north-westwards for a distance of approximately 1,730 feet, to its junction with the disused railway line.
