Notice is hereby given that the South Yorkshire County Council as Highway Authority intend to apply to a Magistrates' Court sitting at the Court House, Moorgate Street, Rotherham at 10 a.m. on Friday, the 25th February 1977, for an Order under section 108 of the Highways Act 1959, for the stopping up of Bow Broom Bridge carrying the old alignment of Queen Street, Swinton in the Borough of Rotherham in the County of South Yorkshire on the grounds that it is unnecessary.

## LONDON BOROUGH OF SUTTON

*The Sutton (Prescribed Route) (No. 1) Traffic Order 1977*

Notice is hereby given that the Greater London Council on 4th January 1977 made the above-mentioned Order under section 6 of the Road Traffic Regulation Act, 1967, as amended by the Transport Act, 1968 and the Road Traffic Act, 1974.

2. The effect of the Order will be:

- (a) to prohibit vehicles the overall width of which together with the load (if any) carried thereon exceeds 7 feet from entering that length of Dorchester Road which lies between a point opposite the party wall of Nos. 1 and 3 Dorchester Road and a point 5 feet south-west of that point;
- (b) to require all other vehicles to proceed in that length of Dorchester Road so as to keep the island site constructed therein on the right or offside of the vehicle.

3. Exemption as been provided in the Order in relation to any vehicle being used for fire brigade, ambulance or police purposes in an emergency.

## LONDON BOROUGH OF BARNET AND BRENT

*The Barnet and Brent (Prescribed Routes) (No. 1) Traffic Order 1977*

Notice is hereby given that the Greater London Council, with the consent of the Secretary of State for the Environment on 4th January 1977 made the above mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Order will be:

- (a) to compel the left turn for vehicular traffic from Brent Park Road into the slip road on the north-east side of West Hendon Broadway;
- (b) to prohibit the right turns by vehicular traffic from West Hendon Broadway into Brent Park Road or Stuart Avenue;
- (c) to prohibit vehicular traffic proceeding in Stuart Avenue from entering West Hendon Broadway;
- (d) to prohibit vehicular traffic proceeding in Waterloo Road from entering North Circular Road.

3. Exemption has been provided in the Order in respect of the requirement and prohibitions referred to in paragraph 2 (a), (c) and (d) above in relation to anything done with the permission or at the direction of a police constable in uniform.
