said sides of lengths of road; the removal of any obstruction to traffic; the maintenance of the road or of the services therein; and in the service of a local authority or of a water authority in pursuance of statutory powers or duties.

Exceptions are provided in the Order for a disabled person's vehicle which displays in a relevant position both a disabled person's badge and parking disc (on which the driver or other person is badge and parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on either of the sides of lengths of road referred to in Schedules 1 and 2 to this notice for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road.

An exception is also provided in the Order for a disabled person's vehicle which displays in the relevant position

abled person's vehicle which displays in the relevant position a disabled person's badge, to wait on the sides of lengths of road referred to in Schedule 3 to this notice.

1. The north-western side of that length of the trunk road known as Newport Road which extends from a point 150 yards north-east of the centre point of the Wye Valley Link Road in a north-easterly direction, for a distance of

165 yards.2. The south-eastern side of that length of the trunk road known as Lower Church Street which extends from a point 10 yards north-east of its junction with Myrtle Place in a north-easterly direction for a distance of 120 yards.

Notice is hereby given by reason of the likelihood of danger to the public the Secretary of State for Wales has made an Order under section 12 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The effect of the Order will be that no person shall cause or permit any vehicle to proceed in:
