Application for a certificate under paragraph 11(1)(A) of the Acquisition of Land (Authorisation Procedure) Act 1946 in respect of Chertsey Poor's Allotment.

Notice is hereby given that Public Local Inquiries will be held by Mr. D. H. Komlosy, B.Sc., (Est. Man) M.R.T.P.I., A.R.I.C.S. (a person appointed by the Secretaries of State for the Environment and Transport for that purpose) for the Environment and Transport for that purpose) beginning at 11 a.m. on Tuesday 8th March 1977 at The Arnold Hall (formerly Ottershaw Infants School) Brox Road, Ottershaw in connection with the draft Orders mentioned below when representations from persons who have objected to the Orders and from any other persons who desire to appear will be heard—and—notice is further given that Mr. Komlosy will at the same time and place hold a Public Local Inquiry into the Secretary of State for the Environment's intention to issue the certificate mentioned below (he being the person appointed by the Secretary of State for the Environment for that purpose) when representations from persons who have objected to such intention and from any other person who desires

to appear will be heard.

The Orders, notice of which was published on 11th
June 1976 in respect of (1) below, 2nd November in
respect of (2) below and on 2nd December in respect of (3) below, which have been prepared in draft by the Secretary of State for Transport under the above mentioned

Acts, are:-

(1) The M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads No. 3) Order

This is an Order under sections 13 and 18 of the Highways Act 1959 and section 62 of the Highways Act 1971 which, if made, will authorise the Secretary of State to:-

- (a) (i) improve, raise, lower or otherwise alter highways; (ii) stop up highways;
  - (iii) construct new highways;
- (iv) stop up private means of access to premises; and (v) provide new means of access to premises; all on or in the vicinity of the route of the Thorpe-

Chertsey section of the M25 motorway.

- (b) provide for the transfer of the said new highways to the Surrey County Council.
- (2) The M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads No. 4) Order.

This is an Order under sections 13 and 18 of the Highways Act 1959 which, if made, will authorise the Secretary of State to provide a new means of access to premises being land comprising part of Ordnance Survey No. 7750 near Lyne in the vicinity of the route of the Thorpe-Chertsey section of the M25 Motorway.

(3) The M25 Motorway (Alm'ners Road-Che. Section) Compulsory Purchase Order (No. CSE ) 19 Road-Chertsey

This is an Order under sections 214 and 215 of the Highways Act 1959, as extended and supplemented by sections 44, 47, 51 and 52 of the Highways Act 1971, under section 22 of the Land Compensation Act 1973 and under section 1 of the Acquisition of Land (Authorisation Procedure) Act 1946, which, if made, will authorise the Secretary of State to purchase compulsorily:—

- (a) the land and rights described in Schedule 1 thereto for the purpose of:
  - (i) the construction of a new special road at Lyne and Chertsey in the District of Runnymede in the County of Surrey in pursuance of the M25 South Orbital Motorway (Egham-Chertsey Section) Scheme 1971,
  - (ii) the construction and improvement of highways and the provision of new means of access to premises

at Lyne and Chertsey in the District of Runnymede in the County of Surrey in pursuance of the M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads No. 3) Order 197, the M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads No. 4) Order 197 and the M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads) Order 1974,

(iii) the discourant of the M25 South Orbital Motorway (Thorpe-Chertsey Section Side Roads) at Lyne and Chertsey in the District of Runnymede

(iii) the diversion of watercourses and the execution other works on watercourses at Lyne and Chertsey in the said District and County in connection with the construction of the special road, the construction and improvement of other highways and the execution of

other works mentioned above, and
(iv) use by the Secretary of State in connection with such construction and improvement of highways and such execution of other works as aforesaid:

(b) the land described in Schedule 2 thereto for the purpose of mitigating any adverse effect which the existence or use of certain of the highways proposed to be constructed by him as mentioned above will have on the surroundings thereof; and

(c) the land described in Schedule 3 thereto for the purpose of being given in exchange for land which forms part of a fuel or field garden allotment.

The intention to issue a Certificate is in respect of that part of the land referred to in (a) (i-iv) above which forms part of the Chertsey Poor's Allotment. The Secretary of part of the Chertsey Poor's Allotment. The Secretary of State for the Environment gave notice on 2nd December 1976 of his intention to give a Certificate in accordance with the Acquisition of Land (Authorisation Procedure) Act 1946, to the effect that other land will be given in exchange for the part of the Chertsey Poor's Allotment proposed to be purchased and the part to be affected by rights which is not less in area and is equally advantageous to any persons entitled to rights of common or other rights. to any persons entitled to rights of common or other rights and to the public or otherwise fulfills the requirements of the Act of 1946 as modified by the Act of 1971 mentioned above.

Copies of the draft Orders with their relevant plans and copies of the notice of the Secretary of State for the Environment's intention to give the exchange land Certifi-cate have been deposited and may be inspected free of cate have been deposited and may be inspected free of charge at all reasonable hours from 18th January 1977 at the Department of Transport, Room P2/038, 2 Marsham Street, London, S.W.1, and the South Eastern Road Construction Unit at Federated House, London Road, Dorking, Surrey and at their Surrey County Sub-Unit, 28-30 High Street, Guildford, Surrey; and at the offices of the Surrey C.C., County Hall, Kingston upon Thames, Surrey; the Runnymede D.C., Council Offices, Station Road, Addlestone, Surrey; at the New Haw Branch Library, The Broadway, New Haw, Byfleet, Surrey and at the Chertsey Branch Library, Guildford Street, Chertsey, Surrey.

Proceedings on the above mentioned Orders are being taken concurrently by virtue of sections 14 and 53 of the Highways Act 1971.

Highways Act 1971.
The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the Inquiries to submit that any highway or proposed highway to which the draft Orders or any of them relate should follow an alternative route, or that, instead of improving, follow an alternative route, or that, instead of improving, diverting or altering a highway to which the draft Orders relate, a new highway should be constructed on a particular route, shall send to the Secretary of State for Transport at the South Eastern Road Construction Unit, Federated House, London Road, Dorking, Surrey RH4 1SZ not later than 4th February 1977 sufficient information about the alternative route or the route of the new highway, as the case may be, to enable it to be identified. Failure to comply with this direction will entitle the Secretaries of State and the person holding the Inquiries to disregard so State and the person holding the Inquiries to disregard so much of any objection as consists of such a submission.
