

The effect of the Order as confirmed is to divert the public footpath known as footpath No. 14 Linton running from the northern most corner of field No. O.S. 8953 at the rear of Warren Drive, Linton, generally in a southerly direction for a distance of approximately 221 metres and the public footpath known as footpath No. 16 Linton running from a point on the eastern boundary of Field No. O.S. 8953 approximately 19 metres south of that field's most northerly corner generally in a westerly direction for a distance of approximately 12 metres so as to run from a point near the northernmost corner of Field No. O.S. 8953 generally in a south-westerly direction for a distance of approximately 6 metres then generally southerly for a distance of approximately 221 metres then north-easterly for a distance of approximately 6 metres to rejoin footpath No. 14.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge at the Council Offices, Midland Road, Swadlincote, between 9.30 a.m. and 12.30 p.m. and 2 p.m. and 5 p.m. Mondays to Fridays.

This Order becomes operative as from 6th January 1977, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act, 1971, or on the ground that any requirement of that Act or any Regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under Schedule 6 of the Town and Country Planning Act, 1971, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.

NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210

Harrogate Borough Council (Tofts Lane, Follifoot) Public Path Diversion Order, 1977

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 13th January 1977, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the Borough of Harrogate as an unopposed Order.

The effect of the Order, if confirmed, without modification, will be to divert the public right of way running from a point at the stile near the corner of Tofts Lane at Oakfield House (Point A) in an easterly direction across O.S. Field 1451 towards Main Street for approximately 185 feet to Point D, to a line running from the said stile near the corner of Tofts Lane at Oakfield House (Point A) in a south-easterly direction adjacent to Tofts Lane for approximately 90 feet (Point B), turning east-north-east along the southern boundary of O.S. Field 1451 for approximately 140 feet (Point C) and then turning west-north-west for approximately 50 feet to rejoin the original line of the path (Point D) some 120 feet from the stile on Main Street. The path will be approximately 4 feet wide throughout its diverted length.

A copy of the Order and the map contained in it has been deposited at the Council Offices, Harrogate, and may be inspected free of charge at the Council Offices, Harrogate, between the hours of 8.45 a.m. and 4.45 p.m. Monday to Friday inclusive.

Council of the Borough of Harrogate (Home Farm, Kirby Hill) Public Path Diversion Order 1977

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 13th January 1977, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the Borough of Harrogate as an unopposed Order.

The effect of the Order, if confirmed, without modification, will be to divert the public right of way running from that part of the public footpath running in an east-south-easterly direction for approximately 95 feet from a Point (A) at the southern end of the buildings at Home Farm, Kirby Hill, and crossing O.S. Field 1335 to Point C, to a line running from that said Point (A) from the southern end of the buildings at Home Farm, Kirby Hill (Point A) for approximately 75 feet running south-south-easterly adjacent to the eastern boundary of 42 St John's Walk, Kirby Hill (Point B) and then running for approximately 65 feet east-north-easterly from the eastern corner of the garden of 42 St. John's Walk, across O.S. Field 1335 (Point C).

Council of the Borough of Harrogate (Knox Mill Lane, Killinghall) Public Path Diversion Order 1977

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 13th January 1977, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the Borough of Harrogate as an unopposed Order.

The effect of the Order, if confirmed, without modification, will be to divert the public right of way running from a point (marked A on the map attached to the Order) approximately 20 yards north-west of Spruisty Bridge, Knox Mill Lane, Killinghall, between The Lodge and No. 1 Knox Mill Lane in a general northerly direction to a point (marked B on the said map) where it bears north-westerly to a point (marked D on the said map) close to the easternmost part of O.S. Field 3190, the total length A-B-D being 130 yards approximately to a line running from the said point A in a general northerly direction following the footpath on the western side of the proposed estate road for approximately 65 yards to a point between the two dwelling sites at the upper end of the site (Point B) at which point it goes roughly north-north-westerly along the boundary between the dwelling sites for approximately 50 yards to the northern boundary of O.S. Field 4183 (Point C) and then south-westerly along the northern boundary of O.S. Field 4183 for approximately 16 yards to meet up with the existing path on the boundary of O.S. Field 4183.
