Any representations or objections with respect to the Order may be sent in writing to the Council not later than 28th February 1977, and should state the grounds on which it is made.

From Fiskerton Road the Boundary turns west opposite Spring Lodge to cross the grounds of Easthorpe Lodge (No. 20 Easthorpe), turns north to follow the eastern (rear) boundary of properties in Farthingate Close, then turns west and south to follow the western (rear) boundary of properties in Farthingate Close. It turns west past the spring to meet the Potwell Dyke and west along the Potwell Dyke to meet Nottingham Road.
