Aylesbury Vale District Council (Parish of Wendover Footpath No. 20) Public Path Diversion Order 1977

Notice is hereby given that the above-mentioned Order made on the 14th January 1977 is about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the Aylesbury Vale District Council.

The effect of the Order, if confirmed without modification, will be to divert the public right of way specified in the First Schedule to this notice to a line specified in the Second Schedule to the said notice.

A copy of the Order and the map contained in it has been deposited, and may be inspected free of charge at the Aylesbury Vale District Council Offices, The Mall, Friars Square, Aylesbury during normal office hours.

Any representation or objection with respect to the Order may be made in writing to the undersigned before the 21st February 1977, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Aylesbury Vale District Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

FIRST SCHEDULE

Description of Site of Existing Path or Way

Commencing from its entrance off the metalled road between Chapel Lane and The Heron Path, Wendover thence continuing in a generally easterly direction for a distance of approximately 74 metres to a point which is approximately 110 metres west of its entrance off Hale Road, Wendover. With a minimum width throughout of approximately 1.8 metres.

SECOND SCHEDULE

Description of Site of Alternative Highway

Commencing from a point referred to in the First Schedule above, then proceeding in a north-north-westerly direction for a distance of approximately 4 metres; then turning to a generally north-easterly direction for a distance of approximately 32 metres, eventually crossing the stream by bridge to a point on the western bank of the stream; then bearing south-easterly for a distance of approximately 10 metres; then turning to an east-north-easterly direction for a distance of approximately 34 metres; then lastly bearing south-easterly turning to a southerly direction for a distance of approximately 20 metres to a point also referred to in the First Schedule above. With a minimum width throughout of approximately 1.8 metres.

Notice is hereby given that the above-named Order, made on 20th January 1977, is about to be submitted to the

Secretary of State for the Environment for confirmation, or to be confirmed as an unopposed Order by the Bedfordshire County Council.

The effect of the Order, if confirmed without modifications will be to divert the public right of way running from a point approximately 160 yards south-west of Old Ways Road southwards for 30 yards to a line running outside the boundary of the cottage at Struttle or Shuttle End in the Parish of Ravensden.

If no representations or objections are duly made, or if any so made are withdrawn, the Bedfordshire County Council may, instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

The Borough of Beverley (Public Footpath No. 3, Skidby) (Diversion) Order 1976

Description of site of existing path

That part of the path in the Parish of Skidby shown on the definitive map of Public Rights of Way as footpath No. 3 from a point at the north-western corner of the property known as 6 Chapel Close shown as point A on the map annexed to the Order and leading in a south-westerly direction for a distance of approximately 104 yards to a point at the north-eastern corner of the property known as 39 Orchard Road shown as point B on the said map.
