- (c) to fix at £5 the amount of the excess daily charges payable by any motorist who leaves his vehicle in one of these parking places without exhibiting a ticket on his vehicle, and to fix at £2 the amount of the excess daily charge payable by any motorist who leaves his vehicle in one of these parking places for longer than any period for which payment was made when the ticket was obtained; and
- (d) to revoke the earlier Orders regulating the use of, and prescribing the charges and method of collecting the charges) payable at, these parking places.

BATH CITY COUNCIL

The Bath City Council (Off-Street Parking Places) Order 1977

Notice is hereby given that the Bath City Council, with the consent of the Avon County Council, propose to make the above Order under Sections 31 and 84 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and by the Local Government Acts 1972 and 1974.

The effect of this proposed Order is:

- (a) to regulate the use of the surface parking place at Broad Street and the multi-storey parking places at Ham Gardens and Walcot Street and, in particular, to specify the classes of vehicles entitled to use such parking places, the conditions on which each of such parking places may be used; and provide for the removal therefrom, and the safe custody of, any vehicle left in such parking places in contravention of this proposed Order;
- (b) to impose the following charges in connection with the use of such parking places and to regulate the method of collecting such charges, namely:

Hourly or Sessional Charges at Broad Street, Ham Gardens and Walcot Street

Motor cars, and motor cycles with three wheels.	Between 8 a.m. and 8 p.m. on weekdays.	10p for the first hour or part thereof; 10p for the second hour or part thereof; and 5p per hour or part thereof after the first two hours.
Motor cycles with two wheels.	Between 8 a.m. and 8 p.m. on weekdays.	15p for the first two hours or part thereof; and 15p for any period thereafter.
Motor cars, motor cycles with three wheels, and motor cycles with two wheels.	Between 8 p.m. and 8 a.m. the following day and at any time on Sundays, Christmas Day, Good Friday and Bank Holidays.	15p for any period.
Motor cars, and motor cycles with three wheels.	Any period of 24 consecutive hours on weekdays.	85p.
Motor cycles with two wheels.	Any period of 24 consecutive hours on weekdays.	45p.
