This Order comes into operation on 23rd January 1977. It revokes the Winchester-Preston Trunk Road (Prohibition of Waiting) (Clearways) (No. 2) Order 1969 and re-enacts it, omitting the old section of the A.34 superseded by the Whitchurch-Litchfield Bypass and including the new lengths of the Bypass. The effect of the Order therefore is to: of the Bypass. The effect of the Order therefore is to:

 Prohibit waiting on any of the main carriageways comprised in about 16 miles of the Winchester-Preston Trunk Road (A.34) which is specified in the Schedule hereto: and

To prohibit waiting by any vehicle for the purpose of trading, unless the goods are immediately delivered at or taken into premises adjacent to the vehicle, on any verge or lay-by adjacent to the said main carriageways.

The prohibition imposed by the Order will not apply:

(a) to a vehicle waiting upon the direction or with the permission of a police constable in uniform, or of a traffic warden;

(b) so as to prevent a vehicle from being used in connection with any building operation or demolition, the removal of any obstruction to traffic, maintenance of the road or of any of the services therein;

(c) to a vehicle being used for fire brigade, ambulance

or police purposes;
(d) to a vehicle being used by or on behalf of a local authority for the purpose of collecting household refuse or clearing cesspools;

(e) to a vehicle waiting in any case where the person in control of it:

(i) is required by law to stop;(ii) is obliged to stop to avoid an accident; or(iii) is prevented from proceeding by circumstances outside his control.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provisions contained therein, on the ground that it is not within the powers of the above Acts, or on the ground that any requirement of those Acts, or of regulations made thereunder, has not been complied with in relation to the Order may within 6 weeks complied with in relation to the Order may, within 6 weeks from 20th January 1977, apply to the High Court for the suspension or quashing of the Order or any provision contained therein.
