*The Dorset County Council (Footpath N8 Bournemouth) Public Path Diversion Order 1976*

Notice is hereby given that on 10th January 1977 the Dorset County Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish that part of the public right of way which runs from a point on Slades Lane approximately 122 metres south of Ensbur Avenue in a south-easterly direction for a distance of approximately 562 metres to meet Boundary Road approximately 122 metres south of its junction with Norton Road. At the same time an alternative highway is created running from a point 162 metres south of Ensbur Avenue in a south-easterly direction for approximately 375 metres to a point approximately 50 metres east of White Farm. It then runs in an easterly direction for a further 200 metres to join Boundary Road approximately 162 metres south of its junction with Norton Road.
