Notice is hereby given that the above-named Orders, made on 17th December 1976, are about to be submitted to the Secretary of State for the Environment for confirmation, or to be confirmed, as unopposed Orders, by the West Sussex County Council.

The effect of the Orders, if confirmed without modification, will be to:

(1) divert part of the public footpath (Path No. 2596) in the Parish of Ashurst, commencing at a point approximately 1,360 feet south-west of Felbridge Cottage, and 60 feet north of the footbridge at the north-west corner of Wappingthorn Wood, and extending generally north-eastwards for a distance of approximately 1,630 feet to its junction with public bridleway (Path No. 2594) and public bridleway (Path No. 2589/1) and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the south-western end of the section of path proposed to be stopped up, extending generally north-eastwards for a distance of approximately 1,460 feet on a south-eastern headland, then eastwards for a distance of approximately 80 feet to joint public bridleway (Path No. 2589/1) at a point approximately 440 feet south-east of its original junction;

(2) divert part of the public footpath (Path No. 2741) in the Parish of Upper Beeding, commencing at its junction with public footpath (Path No. 2745) extending south-eastwards for a distance of approximately 440 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the north-western end of the length of path proposed to be stopped up, extending southwards for a distance of approximately 435 feet on an eastern headland, thence eastwards for a distance of approximately 90 feet on a southern headland, to join the south-eastern end of the length of path proposed to be stopped up;

(3) divert part of the public footpath (Path No. 2743) in the Parish of Upper Beeding, commencing at a point approximately 210 feet east of its junction with public footpath (Path No. 2742) extending southwards for a distance of approximately 130 feet, to its junction with public footpath (Path No. 2741) and substituting for that path a new length of public footpath a minimum width of 6 feet, commencing at the northern end of the length of path proposed to be stopped up, extending eastwards on a northern headland for a distance of approximately 100 feet, thence generally south-eastwards for a distance of approximately 150 feet to its junction with public footpath (Path No. 2741).

(4) divert part of the public footpath (Path No. 275/1) in the Parish of Upper Beeding, commencing at its junction with Road Used as a Public Path (Path No. 2760) extending generally northwards for a distance of approximately 1,230 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at a point on the Road Used as a Public Path (Path No. 2760) approximately 20 feet west of its original junction, extending north-westwards for a distance of approximately 220 feet, thence eastwards for a distance of approximately 220 feet on a southern headland, thence generally northwards for a distance of approximately 670 feet on an eastern headland, thence north-westwards for a distance of approximately 380 feet on a north-eastern headland to rejoin the original route at the northern end of the section of path to be stopped up.
