Notice is hereby given that the Council of the City of Stoke-on-Trent, acting as agents for the County Council of Staffordshire, propose to make an Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order will be to prohibit the waiting of vehicles in:

(a) Baths Road—both sides, from the junction with Times Square to the junction with Corwell Road.

(b) Baths Passage—both sides, the whole length. The provisions of the City of Stoke-on-Trent (Traffic

Regulation) (No. 2) Order 1966 and the City of Stoke-on-Trent (Traffic Regulation) (No. 7) Order 1971 shall be revoked insofar as they relate to the roads and lengths of road referred to.

Both sides of The Green, Neath from a point 150 metres south-west of the junction of Cribb's Row and Commercial Street for a distance of 90 metres in a southerly direction.

West Glamorgan County Council (Margams Park Access Roads, Port Talbot) (Prohibition of Waiting) Order 1977

Notice is hereby given that the West Glamorgan County Council propose to make an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 of the Road Traffic Act 1974, the effect of which will be as follows:

To prohibit waiting at all times on the undermentioned sides of roads:

(1) Margam Park Access Road (Both Sides)

From a point in line with the northern kerb line of the Trunk Road for a distance of 380 metres in a northern and westerly direction to the junction with Star Lane.

(2) Star Lane (Both Sides)

From a point 20 metres of the south side of the Margam Park Access Road to a point 630 metres north therefrom.

From a point in line with the northern side of Margam Park Access Road to its junction with Star Lane a distance of 130 metres approximately.

(4) Spur Road (Both Sides)

From a point in line with the east side of Margam Park Access Road for a distance of 20 metres in an east-erly direction.

(5) East Lodge Access Road (Both Sides)

From a point in line with the western side of Star Lane for a distance of 20 metres in a westerly direction.

Exemptions will be provided in the Order for essential services, loading and unloading facilities, and disabled drivers' vehicles, etc.
