West Glamorgan County Council (Gwilym Road, Cwmlynyfjell) (Prohibition of Waiting) Order 1977

Notice is hereby given that the West Glamorgan County Council propose to make an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, the effect of which will be to prohibit the waiting of vehicles, at any time on the south-western side of Gwilym Road, Cwmlynyfjell from a point opposite the junction with Railway Road to a point opposite the Welfare Hall.

Exemptions will be provided on the Order for essential services, loading and unloading facilities and disabled drivers' vehicles.

Full details of the draft Order together with a map and a statement of reasons for the making of the Order may be inspected during normal office hours at Room 111, The Guildhall, Swansea or at the offices of Lliw Valley Borough Council, Holly Street, Pontardawe.

WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (B.S.C. Access Road/Talbot Road and Talbot Road/Oakwood Lane, Port Talbot) (Prohibition of Right Turns) Order 1977

Notice is hereby given that on 21st January 1977 the West Glamorgan County Council made an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and the effect of which is to:

1. Prohibit vehicles which are travelling along the British Steel Company Access Road from turning right into Talbot Road, Port Talbot.
(The alternative route would be around Station Road roundabout.)
2. Prohibit vehicles which are travelling along Talbot Road from turning right into Oakwood Lane, Port Talbot.
(The alternative route again would be the short detour around Station Road roundabout.)

The Order will come into operation on 24th January 1977 and will be cited as the "West Glamorgan County Council (B.S.C. Access Road/Talbot Road and Talbot Road/Oakwood Lane, Port Talbot) (Prohibition of Right Turns) Order 1977".

If you wish to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date of this Notice apply to the High Court for this purpose.—Dated 24th January 1977.

ROCHDALE BOROUGH COUNCIL

The Greater Manchester County (High Level Road, Rochdale) (Prohibition of Waiting) (Borough) Order 1976

Notice is hereby given that on 20th January 1977 the Rochdale Borough Council pursuant to arrangements made with the Greater Manchester County Council under Section 101 of the Local Government Act 1972 made an Order under Section 1 of the Road Traffic Regulation Act 1967

as amended the effect of which is to prohibit the waiting of vehicles at any time on any day in the lengths of road specified in the Schedule to this notice.

Exemptions are included in the Order to allow vehicles to wait:

- (a) by direction or permission of a police constable in uniform or of a traffic warden;
- (b) to enable persons to board or alight from the vehicle;
- (c) to enable goods to be loaded or unloaded from the vehicle;
- (d) to enable the vehicle to be used in connection with any building or demolition operation and the removal of any obstruction to traffic and the maintenance of roads or the services therein;
- (e) in connection with any statutory undertaking or any statutory duty or power;
- (f) to enable the vehicle to take in petrol, oil, water or air; and
- (g) displaying the appropriate disabled person's badge.

A copy of the Order and a map showing the lengths of road concerned may be inspected at the Information Office, Rochdale Town Hall between the hours of 8.30 am-12.30 pm and 1.30 pm-4.45 pm Mondays to Fridays inclusive.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 20th January 1977 apply to the High Court for this purpose.

This Order will come into effect on 7th February 1977.—Dated 21st January 1977.

SCHEDULE

High Level Road

- (a) North-westerly side for its whole length from its junction with Oldham Road to its junction with Station Road.
- (b) South-easterly side from its junction with Oldham Road for a distance of 30 metres in a southerly direction.
- (c) South-easterly side from its junction with Station Road for a distance of 28 metres in a north-easterly direction.

DEVON COUNTY COUNCIL

The County of Devon (Bishops Palace/Palace Gate, Exeter) (Limitation of Waiting) Order 1977

Notice is hereby given that the Devon County Council propose to make an Order under Section 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended.

When the proposed Order comes into effect you will not be allowed to wait between the hours of 9 a.m.-6 p.m. on any day on either side of the road adjacent to the Bishops Palace commencing with its junction with Palace Gate north-easterly for a distance of 7 metres.

The usual exemptions will apply to the Order, including those applicable to disabled drivers' vehicles.

A copy of the proposed Order, a map showing the affected lengths of road and a statement of the Council's reasons for proposing to make the Order may be inspected during usual office hours, Monday to Friday at Room 3.42, Civic Centre, Exeter.

If you wish to object to the proposed Order, you must send the grounds for your objection, in writing, to the Area County Secretary (East), Civic Centre, Exeter, not later than 25th February 1977.
