HIGHWAYS ACT 1959*Hastings Borough (Path Nos. 383, 384 and 384A)
Public Path Diversion Order 1977*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 10th January 1977 is about to be submitted to the Secretary of State at the Department of the Environment for confirmation or to be confirmed by the Hastings Borough Council as an unopposed Order.

The effect of the Order if confirmed without modifications will be to divert the three public rights of way running northwards from Barley Lane to a line further east running from Barley Lane in a north-westerly direction.

A copy of the Order and the map contained in it has been deposited at the Town Hall, Hastings, East Sussex and may be inspected free of charge at this address during normal office hours.

Compensation for depreciation or damage in consequence of the coming into operation of the Order is payable in accordance with Section 113 (2) of the 1959 Act to which reference should be made.

Any representation or objection with respect to the Order may be sent in writing to the undersigned at the Town Hall, Hastings, East Sussex to arrive not later than 22nd February 1977 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn the Hastings Borough Council may instead of submitting the Order to the Secretary of State aforesaid for confirmation themselves confirm the Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.—Dated 24th January 1977.
