DEPARTMENT OF THE ENVIRONMENT

TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Transport hereby gives notice that on the application of the Rotherham Borough Council, he proposes to make an Order under section 212 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on lengths of highways in the Woodlands Estate/Nelson Road general improvement area at Maltby, Rotherham. The affected highways are mainly to the south of Dunns Dale but including lengths of Highfield Park and Park View north of Dunns Dale.

The proposed Order will contain provisions for permitting the use of those highways by vehicles being used:

- (a) for police, ambulance or fire brigade purposes;
- (b) on behalf of a statutory undertaker or the Post Office or sewage authorities and engaged upon the laying, erection, inspection, maintenance, alteration, repair, renewal or removal of any main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telegraphic line as defined in the Telegraph Act 1878 or any sewer under, in, on, over, along or across the highway or any land adjacent to the highway;
- (c) for the purpose of gaining access to existing garages and driveways.

During 28 days from the 28th January 1977 copies of the draft Order and relevant plan may be inspected at the offices of the Rotherham Borough Council, Civic Building, Frederick Street, Rotherham, and at the Civic Centre, High Street, Maltby, Rotherham, and may be obtained free of
