Proposed Traffic Regulation Orders

Notice is hereby given that, pursuant to the powers delegated to them by the West Midlands County Council under section 101 of the Local Government Act 1972, Coventry City Council propose to make the under-mentioned Orders under section 1 of the Road Traffic Regulation Act 1967, as amended:

(a) City of Coventry (Bus Terminus Roads) (Prohibition of Driving) Order 1977—

This Order seeks to prohibit any vehicle from proceeding in any direction along the purpose-built bus terminus roads situated in or adjacent to the following roads:

(i) Broad Lane at its junction with Banner Lane.

(ii) Droylesdon Park Road at its junction with Rock-land Crescent.

(iii) Jardine Crescent, 200 feet west of its junction with Job's Lane.

(iv) Longford Road at its junction with Longford Square.

(v) Station Avenue at its junction with Torrington

(vi) Wheelwright Lane at its junction with Nunts Lane.

(vii) Winsford Avenue at its junction with Beche Way.

Exemptions will be provided for public service vehicles and vehicles in the service of a local authority in pursuance of statutory powers or duties; emergency vehicles; vehicles being used in connection with the removal of any obstruction to traffic; the maintenance, improve-ment or reconstruction of the roads, sewers, telegraphs or of the supply of gas, water or electricity.

(b) City of Coventry (Various Roads) (Prohibition and Restriction of Waiting) No. 1 Order 1977-

This Order seeks to impose prohibitions or restrictions of waiting on the stated lengths of the under-mentioned roads or new lengths at present under construction adjoining such roads:

(i) Acorn Street, bus turning road adjoining.
(ii) Almond Tree Avenue, bus turning road adjoining.
(iii) Blondvil Street, junction with Quinton Park West.

(iv) Browns Lane, bus turning road adjoining.

- (v) Crescent Avenue, junction with Uxbridge Avenue to cul-de-sac end.
 - (vi) Daventry Road, Quinton Parade Service Road.
 - (vii) Dudley Street, junction with Proffitt Avenue.
- (viii) Emscote Road, junction with Uxbridge Avenue. (ix) Gayer Street, junctions with Old Church Road, Partridge Croft and Proffitt Avenue.
 - (x) Old Church Road, junction with Gayer Street.
 - (xi) Partridge Croft, junction with Gayer Street.
- (xii) Prior Deram Walk, from Sheriff Avenue to/and including the eastern and western link roads.
- (xiii) Proffitt Avenue, junction with Gayer Street/ Dudley Street.
- (xiv) Quinton Park West, from Daventry Road to Blondvil Street.
- (xv) Sheriff Avenue, from Prior Deram Walk to Templars Fields.
- (xvi) Templars Fields, junction with Sheriff Avenue. (xvii) Uxbridge Avenue, junctions with Crescent Avenue and Emscote Road.

Exemptions will be provided for boarding or alighting; loading or unloading; emergency vehicles; local authority vehicles on statutory duties; vehicles engaged on building operations or demolitions in or adjacent to the lengths of road concerned, on the removal of to the lengths of road concerned, on the removal of obstructions to traffic, on the maintenance of the roads, sewers, telegraphs or of the supply of gas, water or electricity; for funeral corteges; for the delivery or collection of postal packets or where a vehicle is required by law to stop, obliged to do so to avoid an accident or prevented from proceeding by circumstances outside the control of the driver and for vehicles used by disabled persone disabled persons.
